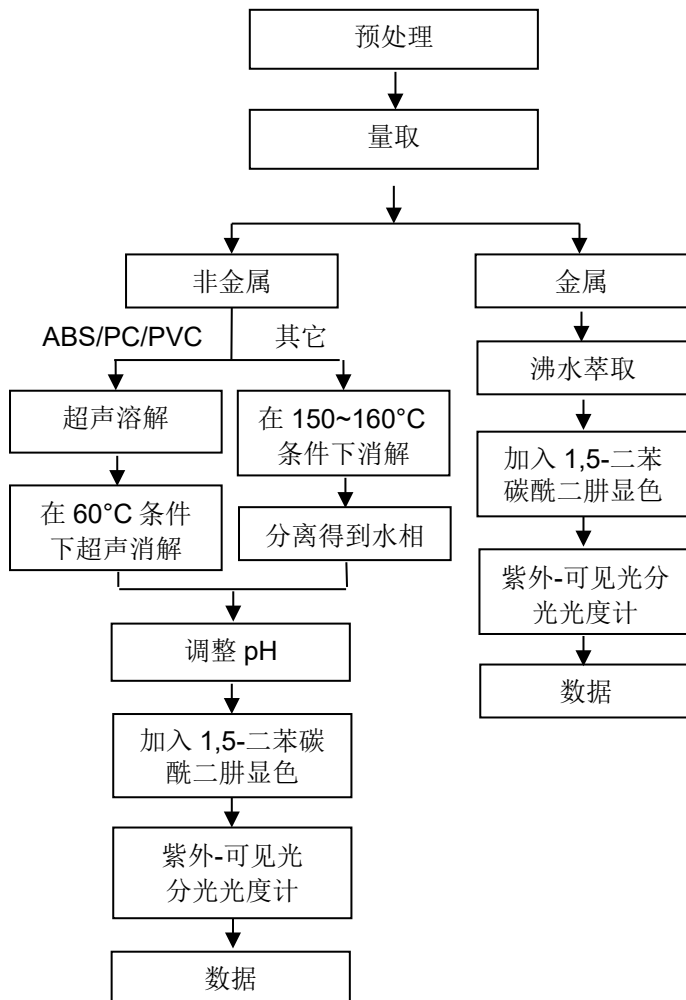

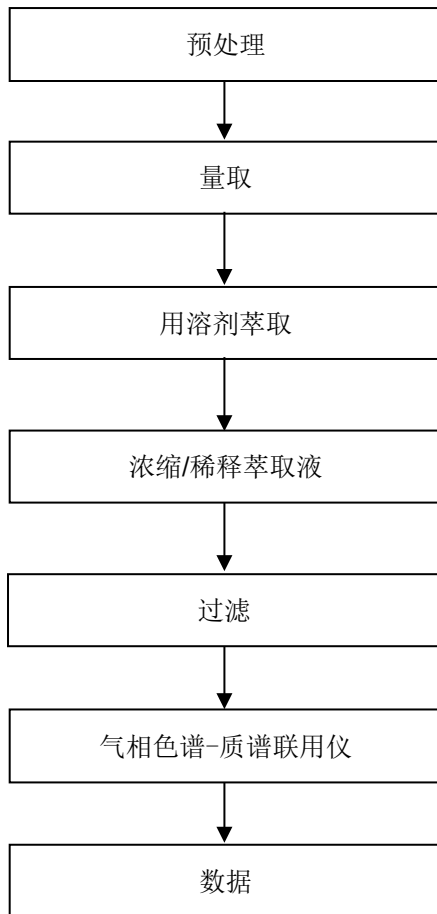

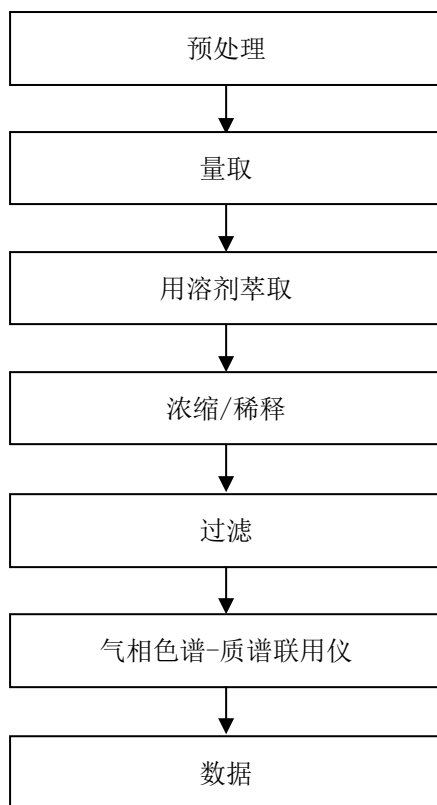
六价铬检测流程图



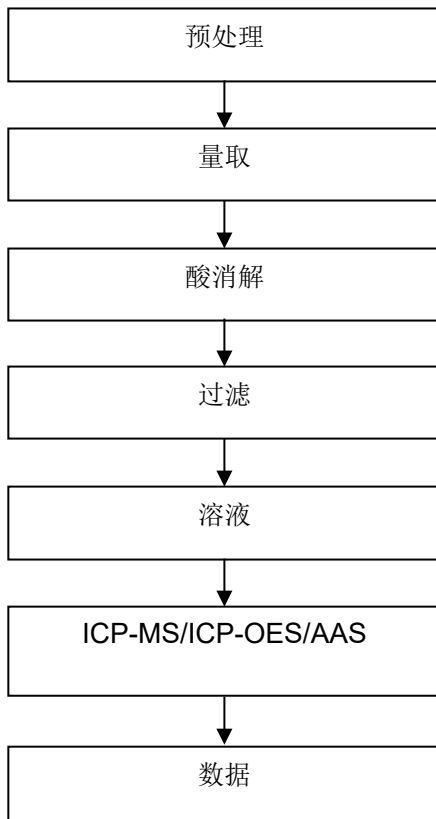
PBB(s)/PBDE(s)检测流程图



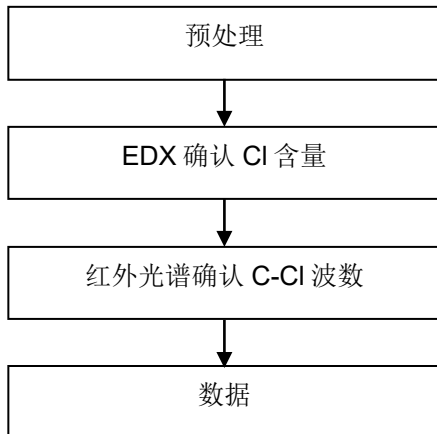
Phthalates 检测流程图

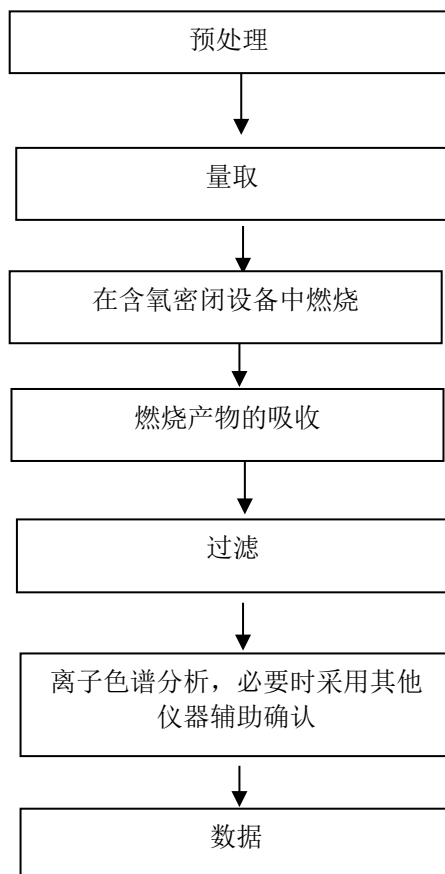


PVC 检测流程图

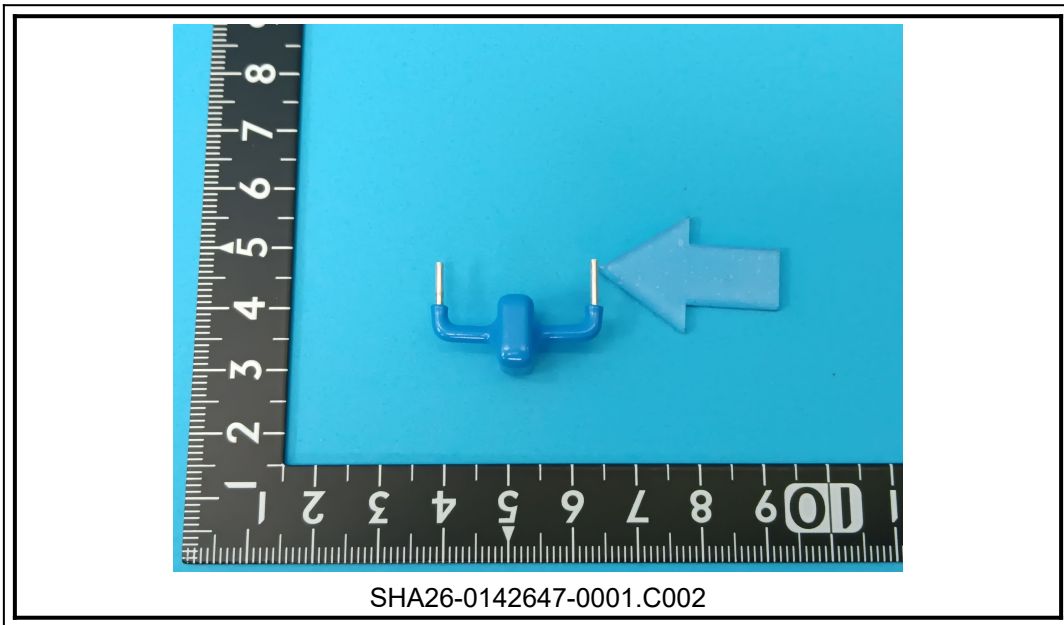
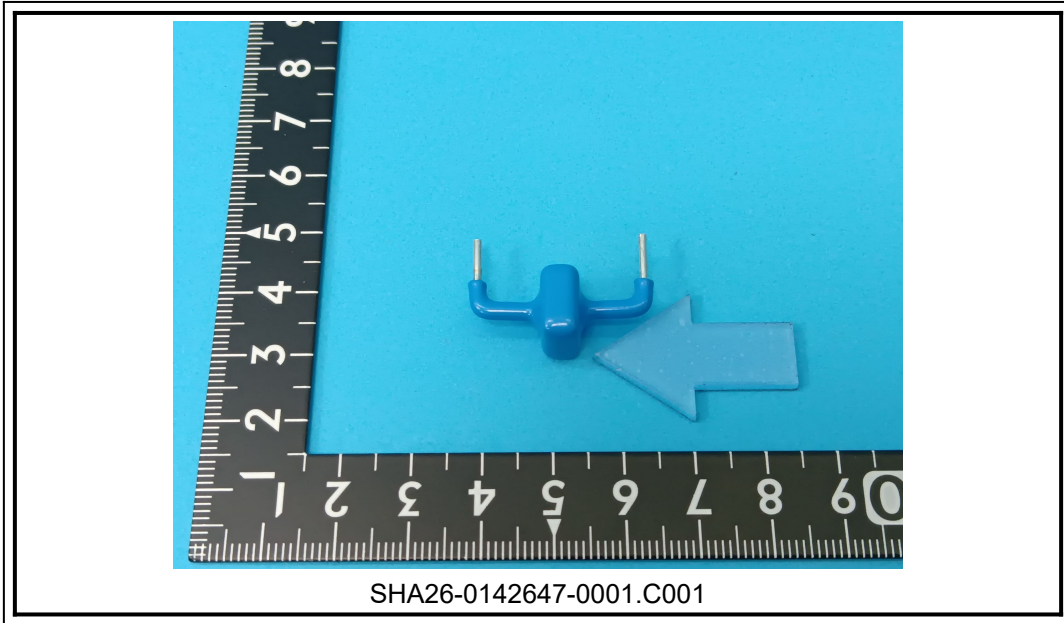
